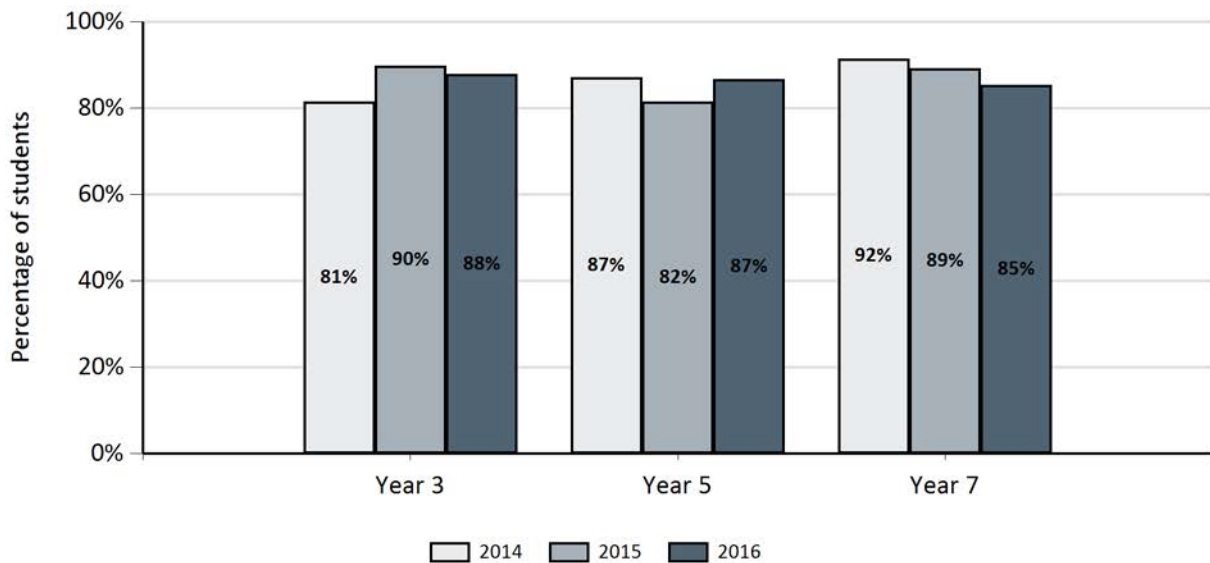

### NAPLAN Proficiency

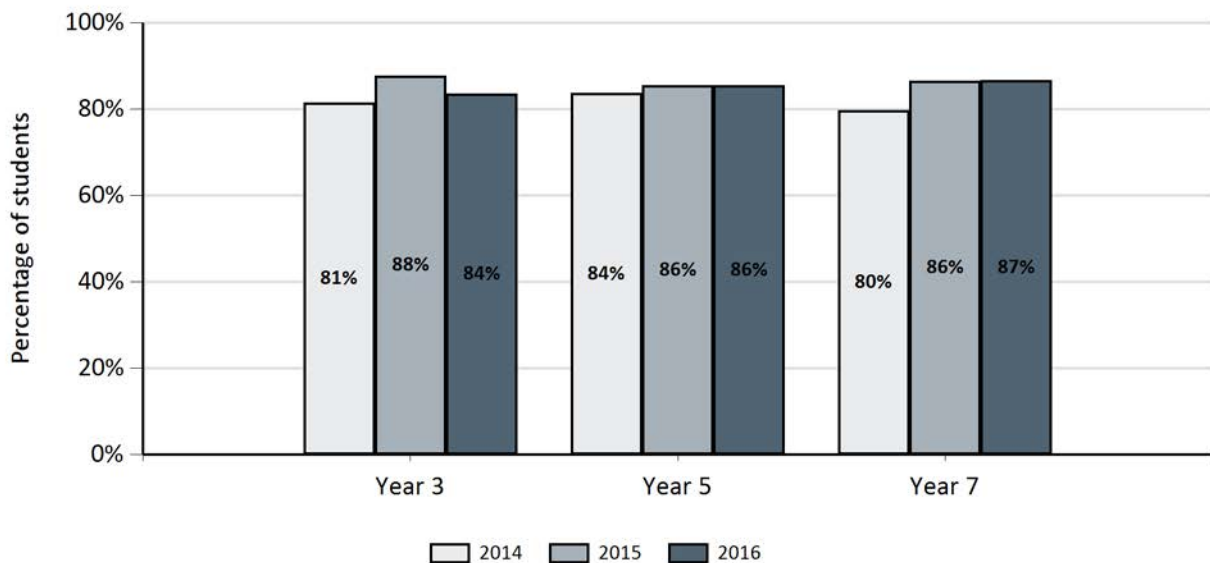
